

The matter was placed before the Council for approval.

**Resolution:** The Council approved the recommendation of Screening and Evaluation Committee for promotion of faculty members under CAS as per the provision of UGC Regulation 2010. The date of fixations/promotion will be from the date of eligibility of the faculty concerned.

**Item No. 3 : Re-Consideration of promotion of Dr. Ramakanta Das, Assistant Professor, Centre for Endangered Languages Manuscriptology and Folklore :**

**EC:115:11-17:3 :** Dr. Ramakanta Das joined as Assistant Professor (Stage I) in Centre for Endangered Languages Manuscriptology and Folklore on 09/11/2009. Dr. Das was promoted as Assistant Professor Stage-III with AGP of Rs. 8,000/- w.e.f. 09/11/2012 (i.e. on completion of three years of service at Assam University, Silchar as per 66<sup>th</sup> Executive Council Resolution No.EC:66:02-09:10) vide Order No.104/19/2012-Estt/7406-16 dated 11/11/2014 by counting his past service as Dr. Das was working as Lecturer Sr. Scale at his parent organisation. The promotion of Dr. Das as Assistant Professor Stage-III was approved by the Executive Council vide Resolution No. EC: 96:08-14:11. The 66<sup>th</sup> Executive Councils decision on counting of past service was revoked and the requirement of minimum 3 years of regular service for promotion/placement under CAS was withdrawn vide Executive Council Resolution No.EC:100:01-15:57. In view of 100<sup>th</sup> Executive Council said resolution Dr. Das applied for promotion as Assistant Professor Stage-III w.e.f. 19/03/2011 as Dr. Das was promoted as Lecturer Sr. Scale w.e.f. 19/03/2006 at his former organisation. The matter was processed for consideration of the authority. While going through the case this has been observed that although Dr. Das was working as Lecturer Sr. Scale in the scale of pay of Rs. 10,000-325-15,200 (Revised scale 15600-39100 AGP-7,000/-), Dr. Das has joined as Assistant Professor against an open advertisement in the scale of pay of Rs. 15,600-39,100 with AGP of Rs. 6,000/- which is a lower scale of pay and hence his pay in the pay band is to be protected and not the grade pay of the previous higher post (Ref; Section 2.3 of DoPT OM No. 28020/1/2010-Estt.(C)). Thereafter, promotion directly to



Assistant Professor Stage-III (AGP 8000) without promoting him to Assistant Professor Stage-II (AGP 7000) at this University is not in accordance with the UGC Regulation 2010. Finance has also opined that promotion of Dr. Das as Assistant Professor Stage-III was not in accordance with UGC guidelines. Hence the matter is placed before Executive Council for re-considering the decision of promotion of Dr. Das as Assistant Professor Stage-III taken by the 96<sup>th</sup> Executive Council meeting. While arriving at any decision it may please be noted that some other teachers were also promoted to Assistant Professor Stage-III directly without being promoted to Assistant Professor Stage-II at this University since they were working as Lecturer Sr. Scale or Selection Grade Lecturer at their parent organisations. As per rule, concerned teachers shall be promoted to Assistant Professor Stage-II at the earliest on confirmation of service in Assam University, provided they are found eligible as per UGC Regulation on counting of past service. Thereafter minimum 5 years service in AGP of Rs. 7000/- is required for further promotion to Assistant Professor Stage-III. Similarly for promotion to Associate Professor & Professor, guidelines as specified in UGC, Regulation, 2010 is necessary to be complied with.

The matter was placed before the Council for decision.

**Resolution :** The Council approved the same in suppression of the earlier decision taken by the 96<sup>th</sup> meeting of Executive Council vide resolution No. EC:96:08-14:11 in the matter of Dr. Ramakanta Das. Accordingly it was decided that skipping of grade pay as per UGC Regulation 2010 is not admissible.

**Item No. 4 : Matter related to promotion of Dr. Joydeep Chakraborty, Assistant Professor, Department of English :**

**EC:115:11-17:4 :** Dr. Joydeep Chakraborty, Assistant Professor Department of English was promoted from Lecturer to Lecturer Sr. Scale under CAS vide Order No.104/19/2010/2540-82 dated 15/11/2013 with a condition that Dr. Chakraborty shall attend one UGC approved Orientation Course and the course must start before the end of 2013 & pay fixation order will be issued separately on confirmation of attendance of Orientation Course. Dr. Chakraborty completed the Orientation Course on 15/03/2016. Dr. Chakraborty failed to comply with the instructions made vide Order No.104/19/2010/2540-82 dated 15/11/2013. His eligibility for promotion under CAS in terms UGC, Regulation, 2000 remained unfulfilled till his completion of orientation course and hence his case was placed before authority for considering his promotion under UGC, Regulation, 2010. The matter was referred to CAS grievance Committee. The Committee opined that the time limit given to Dr. Chakraborty for attending orientation/Refresher course was too short for the incumbent to fulfil, hence the condition for attending an orientation programme may be waived and Dr. Chakraborty may be promoted from the actual date of eligibility. It may be noted here that Dr. Joydip Chakraborty applied for CAS promotion in early part of 2012 and the process of selection/non-selection should have been completed within six months of the date of application as per clause 6.3.1 of UGC





Regulation 2010 and accordingly he was to be intimated. However, after about 18 months in November 2013, he was intimated providing only one month time for completion of Orientation/Refresher Course; i.e by December 2013. The recommendation of the CAS grievance Committee was placed before authority along with administrative views for sympathetic consideration and it has been decided to place the matter before Executive Council to decide on granting promotion from Assistant Professor Stage I to Stage II on the basis of any/all of the following:

1. Dr. Joydip Chakraborty did a 4 week IV Theory/Praxis course organised by UGC recognised Department of English, Berhampur University, Berhampur in 2006 while he was lecturer. The recognition of the Course by UGC could not be traced. However, the matter is placed before Executive Council to consider it as equivalent to an orientation course as it is of equivalent duration and conducted by UGC recognised University.
2. To condone the delay in completion of orientation course as it was not only at the personal level of the incumbent but also seems to be at institutional level. As Dr. Chakraborty applied for promotion in the year 2012 and the condition for attendance of orientation course was communicated in November, 2013.

The matter was placed before Executive Council for decision.

**Resolution :** The Council approved the promotion of Dr. Joydip Chakraborty from Lecturer to Sr. Lecturer under CAS issued vide order No. 104/19/2010/2540-82 dtd 15/11/2013.

**Item No. 5 : Payment of Honorarium for Evaluation of Research publications by External Experts for consideration in CAS Promotion :**

**EC:115:11-17:5 :** The external subject experts who are evaluating research publication/books etc of the internal candidates applied for and to be considered under CAS promotions [Asstt Professor Stage 3 to Associate Professor and Associate Professor to Professor] are entitled for payment of honorarium after evaluation of the publications send to them. The external experts have been paid an honorarium @ ₹ 1000/- per expert per candidates as in the case of external experts are paid for PhD thesis evaluation. Some experts have requested for enhancement of honorarium for Evaluation of Research publications under CAS promotions. Hence it is proposed that an enhanced rate for the job may be fixed to the tune of ₹ 1500/- and \$ 25 (for foreign examiner of SAARC countries) per expert per candidate. The matter was placed before the council for approval.

**Resolution :** The Council opined that the proposal for enhancement of honorarium for evaluation of research publications should be placed before the Finance Committee with proper justification on recommendation of Academic Council, thereafter the same may be placed in the EC for final approval.





**Item No. 6 : Correction in the minutes of the last EC regarding the matter of Dr. V. K. Rao :**

**EC:115:11-17:6 :** The decision of the EC in its 111<sup>th</sup> meeting held on 20/5/2017 regarding the matter of Dr. V. K. Rao was as under:

“The matter of lien in respect to Dr. Vinay Kumar Rao, Assistant Professor, Dept of History was discussed in detail. After a long deliberation on his issue the Council decided to consider Dr. Vinay K Rao to have deemed to be resigned from the date of initiation of lien....” As per Regulation on grant of Lien of Assam University the decision may be corrected as “The Council decided to consider Dr Vinay K Rao to have deemed to be resigned from the date of violation of terms of lien granted to him.....”(i.e his date of joining in Central University of Haryana from Central University of Punjab for which lien was granted).

The item was placed before the Council for perusal and approval.

**Resolution :** The Council approved the same.

**Item No. 7 : Annual Report for the year 2016-17 :**

**EC:115:11-17:7 :** The Director, IQAC has submitted the copy of the Annual Report of Assam University, Silchar, for the year 2016-17 for perusal and approval by the Executive Council to facilitate the IQAC for onward submission to the concerned Ministry.

**Resolution :** The Council approved the Annual Report 2016-17 for onward submission to the Ministry. Further, the Council suggested that the Annual Report be prepared and placed in the Executive Council every year in the month of August.

**Item No. 8 : Recommendation of the 46<sup>th</sup> meeting of the Finance Committee of the Assam University slated for 17<sup>th</sup> November 2017 :**

**EC:115:11-17:8 :** The 46<sup>th</sup> meeting of the Finance Committee of the University slated for 17<sup>th</sup> November 2017 at AIU House, New Delhi. The Minutes of the Finance Committee was placed in the meeting for approval of the Council.

**Resolution :** The Council approved the recommendation of 46<sup>th</sup> meeting of the Finance Committee of Assam University held on 17<sup>th</sup> November 2017.

**Item No. 9 : Matter related to 88<sup>th</sup> meeting of the Building Committee :**

**EC:115:11-17:9 :** The 88<sup>th</sup> meeting of the Building Committee was held on 25<sup>th</sup> October 2017. The minutes of 88<sup>th</sup> meeting of Building Committee was placed before the Council for approval.





**Resolution :** The Council approved the recommendation of 88<sup>th</sup> meeting of the Building Committee held on 25<sup>th</sup> October 2017 subject to recommendation/comments of the Finance Committee.

**Item No. 10 : Recruitment & Promotion Policy 2013 of Non-Teaching Employee:**

**EC:115:11-17:10 :** The 111<sup>th</sup> meeting of Executive Council approved the Recruitment & Promotion Policy 2013 of Non-Teaching Employee. However, the Council authorized the Vice Chancellor to take necessary action to the effect that the same shall be placed for administrative scrutiny. The matter has been scrutinized by the administration as per UGC/GOI guidelines and with concerned EC resolutions. The vetted Recruitment & Promotion Policy 2013 (modified in 2017) was placed in the meeting. The matter was placed before the Council for final approval.

**Resolution :** The Council considered the issues related to respective non-teaching cadres and after obtaining views of the member concerned on the amended RR it was unanimously resolved to refer the entire RR 2013 (Amended 2017) to UGC for vetting before implementation.

**Item No. 11 : Quarter Allotment Rules/Regulations for Assam University (Non-Teaching & Teaching staff) :**

**EC:115:11-17:11 :** A committee was constituted vide No, AUG/QRTR-06/NT&T/2013 Vol-I dtd. 08/12/2016 to prepare and submit a draft "Quarter Allotment Rules/Regulations" for Assam University (Non-Teaching & Teaching staff) so as to facilitate allotment of quarters. The committee after due examination of relevant rules as well as consultation of other Central Universities rules for allotment of quarter etc. has submitted the draft Rules & Regulations. The said draft has been perused by the competent authorities and placed before the Council for approval and adoption.

**Resolution :** The Council advised to constitute a Committee under the Chairmanship of Prof. Sanjib Das, Dean, School of Medical & Pharmaceutical Science and one representative each from AUTA & AUNTEA to look into the matter and also suggested to upload the draft "Quarter Allotment Rules/Regulations" in the website of the University for information and comments from the beneficiaries, if any.

**Item No. 12 : The Minutes of the 51<sup>st</sup> & 52<sup>nd</sup> meeting of the Affiliation Committee:**

**EC:115:11-17:12 :** The Director, CDC has submitted the Minutes of the 51<sup>st</sup> & 52<sup>nd</sup> meeting of the Affiliation Committee held on 18<sup>th</sup> May 2017 & 18<sup>th</sup> July 2017 respectively for consideration and approval of the Council. The matter was placed before the Academic Council for consideration and approval.





The matter was accepted in the 79<sup>th</sup> meeting of the Academic Council held on 25<sup>th</sup> October 2017 vide resolution No. AC:79:10-17:2 and recommended the same to the Executive Council for final approval.

**Resolution :** The Council noted and approved the same.

**Item No. 13 : Course structure and syllabus of B.Voc. (Information Technology):**

**EC:115:11-17:13 :** The Director, CDC has submitted the Course structure and syllabus of B.Voc. (Information Technology) which was prepared by the BUGS, Computer Science. The relevant papers were placed in the AC meeting for consideration and approval.

The matter was accepted in the 79<sup>th</sup> meeting of the Academic Council held on 25<sup>th</sup> October 2017 vide resolution No. AC:79:10-17:3 and recommended the same to the Executive Council for final approval.

**Resolution :** The Council noted and approved the same.

**Item No. 14 : Syllabus (non CBCS) for Ecology & Environmental Science(Hons) :**

**EC:115:11-17:14 :** The Director, CDC has submitted the Syllabus (non CBCS) for Ecology & Environmental Science (Hons). The relevant papers were placed in the Academic Council meeting for consideration and approval.

The matter was accepted in the 79<sup>th</sup> meeting of the Academic Council held on 25<sup>th</sup> October 2017 vide resolution No. AC:79:10-17:4 and recommended the same to the Executive Council for final approval.

**Resolution :** The Council noted and approved the same.

**Item No. 15 : Minor Modification in PG (CBCS) Syllabus. Dept. of Sanskrit :**

**EC:115:11-17:15 :** The Dean, Rabindranath Tagore School of Indian Languages and Cultural Studies has submitted the proposal of the following Minor Modification in PG (CBCS) Syllabus for the Dept. of Sanskrit.

The course content will remain the same where 203 will be 204 and 204 will be 203(open choice). The above matter was placed before the AC meeting for consideration and approval.

The matter was accepted in the 79<sup>th</sup> meeting of the Academic Council held on 25<sup>th</sup> October 2017 vide resolution No. AC:79:10-17:11 and recommended the same to the Executive Council for final approval.

**Resolution :** The Council noted and approved the same.



**Item No. 16 : ICSI Signature Award :**

**EC:115:11-17:16 :** The **Institute of Company Secretaries in India (ICSI)** has applied for signature Award to the topper of B.Com degree examination as submitted by the Dean of M. G. School of Economics & Commerce. The School Board noted the proposal of ICSI and resolved to forward the same to the Academic Council for consideration.

The matter was accepted in the **79<sup>th</sup> meeting of the Academic Council** held on 25<sup>th</sup> October 2017 vide resolution No. **AC:79:10-17:12** and resolved to approve the ICSI Signature Award for implementation. The Academic Council also advised the concerned Dean of Schools to forward such proposal wherever applicable to the University authority. The same was recommended to the Executive Council for final approval.

**Resolution :** The Council noted and approved the same.

**Item No. 17 : Ratification of Assam University Regulations regarding B. Voc course :**

**EC:115:11-17:17 :** The Dean, HK School of Life Sciences has submitted the proposal for ratification of Assam University Regulations regarding B. Voc course.


In accordance with the Notification issued by the Registrar (No. AUK-201/30/2016-17 dated 04/08/2017), the Nodal Officer of the B. Voc course (i.e. Director, CDC, AUS) has submitted the Assam University Regulations regarding B. Voc course and the same has been forwarded to AC by the 10<sup>th</sup> BUGS meeting of Dept. of Biotechnology held on 14/08/2017. The B. Voc students have been attached to Dept of Biotechnology for University registration purpose. The syllabus of the said course was ratified earlier by the AC meeting resolution no. AC:75:04-16:20.3. The Regulation of B. Voc course as proposed now was placed before the Academic Council for consideration and approval.

The matter was accepted in the **79<sup>th</sup> meeting of the Academic Council** held on 25<sup>th</sup> October 2017 vide resolution No. **AC:79:10-17:14** and resolved that the word **Regulations** is to be replaced by **Ordinance**. The B. Voc students have been attached to Dept of Biotechnology for University registration and also for all academic purposes. The Council recommended to the Executive Council for approval.

**Resolution :** The Council noted and approved the same.

**Item No. 18 : UGCs proposal for reviewing of curricula of academic depts.**

**EC:115:11-17:18 :** The UGC vide letter No. D.O. No. 9-2/2017(CPP-II) dtd. 31<sup>st</sup> January 2017 has communicated the recommendation of the meeting of Secretaries on Education and Social Development with the Hon'ble Prime Minister and recommended that curricula of all academic departments in Universities should be reviewed and revised at least once in every three years. This review and revision of academic curricula should focus on the





existing and potential demand and supply of skill sets to make the University/College students employable.

The matter was accepted in the 79<sup>th</sup> meeting of the Academic Council held on 25<sup>th</sup> October 2017 vide resolution No. AC:79:10-17:22 and recommended the same to the Executive Council for final approval.

**Resolution :** The Council noted and approved the same.

**Item No. 19 : Holding of XVIth Convocation :**



Dr. Rajesh Seth, Asstt. Prof., was relieved from Assam University, Diphu campus on 15.02.2016 with grant of EOL for one year effective from 16.02.2016 subject to ratification by the E.C. The one year period of EOL has been expired on 15.02.2017.


The Pro Vice Chancellor, Diphu campus has placed a proposal since, there has been no communication regarding confirmation of service of Dr. Rajesh Seth in Berhampur University. Considering the acute scarcity of faculty in Political Science department, AUDC leading to students' unrest it is proposed that EOL for another one year to Dr. Rajesh Seth may be not granted and he may be directed to rejoin the parent University or tender resignation with immediate effect. The matter was placed before the Council for ratification.

**Resolution:** The Council approved the same and declined the request of EOL and advised to inform the employee to join AUDC by giving a reasonable time by the Pro. Vice Chancellor, AUDC.

**Resolution :** ICC report against Prof. Samira Behera, Professor, Dept. of Mathematics was read out and Council found that, since the complain was not established and hence the complainant may be communicated to devour from raising such issues in future without sustentative evidences.

Dr. Habibur Rahman Laskar, Asstt. Professor, Dept. of Business Administration has applied for grant of Extra Ordinary Leave (EOL) for 05 years to accept an invitation to the




post of Assistant Professor at AI Baha University, Ministry of Education, Kingdom of Saudi Arabia (KSA). He wants to join his new assignment by fall of 2017. It may be noted that Dr. Laskar has completed 05 years' service in this University. As per UGC Regulation 2010, EOL can be granted to accept an invitation to a teaching post. However, as per Assam University Ordinance EOL cannot be granted for more than two years though UGC Regulation 2010 has provision of granting EOL in combination with other leave for a maximum period of 03 years. Hence Dr. Laskar may be granted 02 years' EOL to join teaching assignment at AI Baha University, KSA. The item was placed before the Council for perusal and approval.

**Resolution :** The Council approved the grant of EOL to Dr. Habibur Rahman Laskar, Asstt. Professor, Dept. of Business Administration for a period of 01 (one) year.
