2. Unit nos. 2 and 3 of the paper SEC - II are to be merged into a single unit so as to make it a 5-unit paper to keep parity with other papers.
Skill Enhancement Course papers ECO SEC paper - 501
Entrepreneurship and Small Business Development SEC - 601.

The UGC has also approved the intake capacity 50 students per course and appointment of faculty and staff as per the provisions of the NSQF Guidelines. Also instructed to ensure compliance of the terms of conditions/provisions as laid down in the Guidelines for providing Skill-based Education under National Skill Qualification Framework (NSQF).

Since Social Work is an integrated professional course designed with mandatory practice oriented syllabus. To meet with the practice objective, the students go to the field for two days in a week. Above all, the Open Elective Courses offered by other Departments are not suited to Social Work discipline. Hence Social Work Department may be given exemption from offering the OE courses for the students of other Departments.

The matter was placed before the Council for consideration and approval.

Resolution : The Council perused the matter and exempted as submitted. The Council recommended the same to the EC for approval.

Item No. 27 : Provision for Lateral Entry in direct MSW in Department of Social Work :

AC:82:09-18:27 : The Dean, Jadunath Sarkar School of Social Sciences has proposed the provision for Lateral Entry in direct MSW in Department of Social Work.

Every year there is vacancy of 8 to 10 seats in MSW as some of our students go out for further study in other institutions after completing BSW. To fill up the said vacant seats, the department wants to start lateral entry provision by conducting separate MSW Entrance Examination for the candidates from other Universities who wish to take admission in MSW directly. This lateral entry provision should be given to only those who have completed BSW.

The matter was placed before the Council for consideration.

Resolution : The Council agreed in principle and resolved that it may be considered subject to decision taken in consultation with the Admission Committee.

Item No. 28 : Modified TDC Syllabus (CBCS) of Arabic :

AC:82:09-18:28 : The Head, Dept. of Arabic has proposed the modified TDC Syllabus (CBCS) of Arabic. The syllabus was placed in the meeting by the HOD concerned. The matter was placed before the Council for consideration and approval.




Item No. 35.1 : Adoption of UGC Regulation 2018 :
