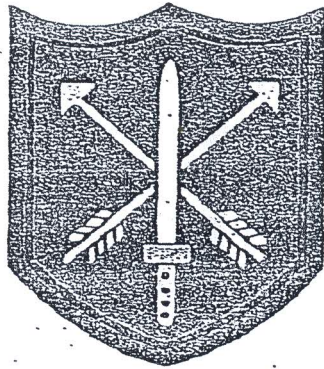

ASSAM UNIVERSITY AND CIJW SCHOOL

MEMORANDUM OF UNDERSTANDING

BETWEEN

ASSAM UNIVERSITY, SILCHAR

AND

COUNTER INSURGENCY AND JUNGLE WARFARE SCHOOL

This Memorandum of Understanding (MoU) between The Assam University, Silchar as Party No. 1 and Counter Insurgency and Jungle Warfare School (CIJW) School as Party No 2, referred to as Coordinator on this day the 29th February, 2012 herein after jointly referred to as "Parties" whereas the parties have agreed relating to the grant of Post Graduate Degrees/Diploma to the Instructors of CIJW School who are imparting instructions to students coming for training at CIJW School from India and abroad.


Now, this MOU witnesses as follows :

1. Admission will be made for the following courses of Assam University as per the number of seats mentioned against each in accordance with the terms and conditions of this MoU and regulations of the University :-


<u>Ser No</u>	<u>Name of the Course</u>
(a)	Ph D all subjects of Social Sciences and Humanities.
(b)	Research Scholars in South Asian studies.
(c)	Post Graduate Diplomas in selected disciplines.

2. The duly filled in applications for admissions should be submitted to the University by the dates as specified by the University every year.

3. If the applications are not received within the prescribed date, the seats may be filled by the University itself, in whatever manner it deems fit.



4. The fee will be paid at the normal rates prescribed for other students or at mutually agreed upon fee structure between the University and the CIJW School.
5. The theory and / or practical classes shall be conducted by CIJW School using its own infrastructural facilities such as classrooms, equipments, analytical tools and aids, library etc, and qualified staff as required for each course.
6. Apart from its own faculty, CIJW School shall utilize the services of qualified and experienced professionals from other institutions with approval from Assam University.
7. CIJW School shall arrange and assess continuously the knowledge gained, performance status, skills developed etc., by the students for the apportioned marks as per the approved scheme of examinations through classroom tests and assignments, furnish the details of marks in the specified format to the Controller of Examinations when required.
8. The nominated army personnel shall, write the Examinations at an exclusive centre at a mutually convenient location. A separate merit list will be prepared for these seats from amongst the Army candidates.
9. Students will abide by the rules and regulations of the University from the date of their admission/joining.
10. The university, apart from conducting examinations shall evaluate answer scripts and publish the results, issue statement of marks and other certificates and award the degree.
12. The term Army nominees will include serving Army personnel only.



13. A Joint Committee will be formed to take the process forward and also examine further areas of cooperation. The recommendations of the Joint Committee on any matter referred to it under this scheme will be placed before the appropriate bodies of the University for approval. The committee will consist of two members each from both parties and will be chaired by the VC.

APPROVAL

This MoU is subject to the approval of the competent authorities of both the parties and also subject to the relevant laws of the land. The approvals would be deemed to be in place once the MoU is signed.

DATE OF EFFECT


This MoU shall take effect from the date it is signed by the authorized representative of the parties and will be in force for a period of five years after which it would be reviewed.

MODIFICATION

The terms of the MoU may be modified, if and when required, with the consent of both the parties.


TERMINATION

Either party shall be entitled to terminate this MoU by providing the other party with six calendar months advance notice. The termination of this MoU for whatever reason will not affect the right of a party, which may have accrued as the date of termination and will further not affect any rights which specifically or by their nature survive the termination of the MoU.




In agreement of the above objectives and terms and conditions, this Memorandum of Understanding is hereby signed by the below mentioned parties on the 29th February 2012.




