At the outset the Vice-Chancellor being the Chairman welcomed all the members of the Executive Council, Deans of Schools and other Officers. Thereafter the Vice Chancellor informed the house the issues relating to on-going student protest, especially related to Non-NET Fellowship for the scholars enrolled in 2019. After threadbare discussion, the following resolutions were adopted unanimously.

## Item No. 1: Grant of Non-NET Fellowship of 10 months to scholars enrolled in 2019:

EC:130:12-19:01: In view of fund constraint for Non-NET Fellowship, the Council after threadbare discussion of release of claim of Non-NET Fellowship for scholars enrolled in 2019 for the period January to October 2019, decided that fellowship for Non-NET scholars enrolled in 2019 shall be disbursed for the period January to October 2019 by 31st December 2019 as per representation of the students keeping in mind the ongoing unrest situation amongst students. However, further Fellowship to Non-NET scholars shall be made available for financial year 2019-20 subject to approval and release of additional grant by UGC.

## Item No. 2: Period of Non-NET Fellowship for M.Phil/Ph.D. Scholars under Ph.D. Regulation 2016:

EC:130:12-19:02: The Council reviewed the issue relating to period of grant of Non-NET Fellowship which was initially approved by the University for 18 months for M.Phil Scholars and 03 years for Ph.D. Scholars and resolved that the period of Non-NET Fellowship under Ph.D. Regulation 2016 for M. Phil shall be 18 months and for Ph.D. candidates shall be 04 years.
