## 19<sup>th</sup> CONVOCATION 2022 NOTIFICATION

The 19<sup>th</sup> Convocation of Assam University is scheduled to be held on 6<sup>th</sup> April, 2022 in Assam University, Silchar campus.

The Degree that will be conferred in the 19<sup>th</sup> Convocation is as follows:

1. For M.Phil and Ph.D : Degree awarded on and from 22/01/2020 till the last date of submission of Application form for entering into 19<sup>th</sup> Convocation, 2022.
2. For all other Courses:
  - (a) Post Graduate Courses- Candidates passed out in 2020 and 2021.
  - (b) Engineering and Pharmaceutical Science-Candidates passed out in 2020 and 2021.
  - (c) Integrated Courses-Candidates passed out in 2020 and 2021.
  - (d) Under Graduate Courses- Candidates passed out in 2020 and 2021.
  - (e) Three Years Degree Course- Candidates passed out -
    - (i) Non-CBCS, Odd Semester, November-December 2019.
    - (ii) Non-CBCS, Even Semester, September, 2020.
    - (iii) Non-CBCS, Odd Semester, April-May 2021.
  - (f) Professional Courses:
    - (i) B.Ed-Passed out in 2020 and 2021.
    - (ii) Law-Passed out in 2020 and 2021.
  - (g) B.Voc : Passed out in 2020 and 2021.
  - (h) Diploma Courses: Passed out in 2019, 2020 and 2021.

The Candidates, who are eligible and willing to attend the Convocation should apply online for Registering in the prescribed Online Form available in <https://www.ausexamination.ac.in/certificate> w.e.f 12:30pm of 11<sup>th</sup> February 2022 onwards. Last date of submission of application forms along with all supporting documents is 20<sup>th</sup> February 2022 upto 12:00 midnight.

The Fee Structure for registering into 19<sup>th</sup> Convocation is as follows:

- (i) For, those willing to participate PHYSICALLY-Rs.2000/-+ payment gateway charge as applicable.
- (ii) For, those, cannot participate physically-Rs.1200/-+ payment gateway charge as applicable.

The amount paid is non refundable. Application fee of candidates who are not eligible as per Para.2 above, for 19<sup>th</sup> Convocation 2022, will not be refunded. Candidates are requested to use "RuPay" Debit Card or "Internet Banking" for payment of fees through payment Gateway. The students willing to attend the Convocation physically will receive Hall Ticket by 4<sup>th</sup> April 2022.

There will be a Rehearsal on 5<sup>th</sup> April 2022 at Assam University, Silchar Campus for those attending the Convocation. Applicants must report to the University Campus by 10:30 A.M. of the 5<sup>th</sup> April 2022 for the same and for collection of Convocation Gown etc. Participation in the rehearsal is compulsory for all candidates who are willing to attend the Convocation physically.
