The candidates must report to the Department at least 45 minutes before the scheduled time of RET and submit the following to the department office.

i) Self attested copies of marksheets and other supporting documents including caste certificates (if any). If degree results are shown in grades, the candidates must submit Grade to Percentage conversion formula as used by the concerned Universities.

ii) Self attested copy of valid EWS certificate, Non-creamy layer certificate (for OBC category) and PWD certificate, as the case may be.

iii) Copy of Fee payment receipt generated through Assam University, Silchar admission portal.


(iv) Self attested copy of any other documents that they have submitted along with their online application.
