Thereafter the meeting formally started and following agenda items were taken up for discussion and resolutions were adopted accordingly.

(A) Agenda item for confirmation:

Item No.1 : Confirmation of the minutes of the 156th meeting of the Executive Council :

The Regulations as notified required to be adopted by the University.

Resolution : The University Grants Commission (Institutions Deemed to be Universities) Regulations, 2023 were perused by the members and after consideration of the contents in the Regulations the Council authorised the Vice Chancellor to constitute a Committee to look into the detail of the Regulations and to find whether the same is applicable for Central Universities like Assam University for which there is already laid down Acts and statutes and submit its report to Vice Chancellor at the earliest.

Item No. 3 : Appointment of "Assistant Professor" under Dr. Ambedkar Chair Scheme :

EC:157:06-23:03 : The Dr. Ambedkar Foundation, Ministry of Social Justice and Empowerment, Government of India have granted a tenure based position of **Assistant Professor** under the Dr. Ambedkar Chair Scheme. The Assam University has followed the timeline given by the Dr. Ambedkar Foundation for the selection process, i.e., employment notification, notification of the Screening Committee, shortlisting of candidates, notice of shortlisting of candidates and the constitution of the Selection Committee as provided under clause 5.1.III of UGC Regulations 2018. The duly constituted Selection Committee under the Chairmanship of Prof Rajive Mohan Pant, Vice-Chancellor, in its meeting dtd. 16th May 2023 has recommended the following names in order of merit for appointment as **Assistant Professor** against Dr. Ambedkar Chair Scheme. The matter was relooked into and was examined by former Director ISTM, Mr. K G Verma and it is required that the said notification is to be cancelled and fresh employment notification shall be issued as per modified earmarking of vacancies. Item No. 7 : Proposal from Dean, TSSOT reg- Utilising of the School Development Fund (SDF) & Department Development Fund (DDF) :

EC:157:06-23:07 : The Dean, Triguna Sen School of Technology (TSSOT) has submitted a proposal to reconsider the policy for utilizing the School Development Fund (SDF) & Department Development Fund (DDF) as was decided in the 155th EC meeting vide resolution no. **EC:155:02-23:19**. The concerned School Affairs Committee meeting dtd. 17-05-2023 has expressed that there were several expenditures which were planned prior to the adoption of this policy and requested the Chairman of the Executive Council to reconsider the matter as the said fees taken from the students were utilized for the academic purposes of the School and development of the Departments.

The Annual Accounts of the University for the financial year 2022-23 with due recommendations of the 67th meeting of the Finance Committee of Assam University slated on 12th June 2023 vide Agenda Item No. FC:67/04 under Section 19 (7) of the Statutes of the University is placed before the Executive Council for approval and adoption and further submission to the Comptroller & Auditor General of India for certification.

The Annual Accounts of the Assam University for the Financial Year 2022-23 was duly recommended by the 67th meeting of the Finance Committee of Assam University held on 12th June 2023 vide Agenda Item No. FC:67/04.

The Executive Council authorised the Vice-Chancellor to forward the Annual Accounts of the Assam University for the Financial Year 2022-23 to the Comptroller & Auditor General of India, Branch Office, Guwahati for taking up audit of Assam University and certification of Annual Accounts.

Item No. 11 : Reconsideration of decision of the 155th meeting of the Executive Council vide resolution No. EC:155:02-23:11 :

EC:157:06-23:11 : On the matter of creation of "Assam University Guest House Receipt Fund" and the utilization of the said fund it was decided in the 155th meeting of the Executive Council vide resolution No. EC:155:02-23:11 that the expenses required for Guest House including Capital Expenditure from time to time may be met up from the fund generated and the same shall be effected from April 01, 2023. Now on receipt of some observations it is proposed that the fund to be generated under the said Head may be used as like the decision taken in respect to utilization of **Annual Course Fee Fund**. The matter is placed before the Council for consideration and approval.

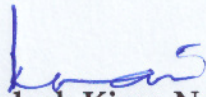

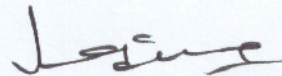
