Online applications are invited for admission to the following courses of study in Assam University, Silchar H.Q. for the academic session commencing from 2023-24.

4-Semester M. Tech Programme:

a. Agricultural Engineering, b. Computer Science & Engineering and c. Electronics & Communication Engineering.

Candidates may apply online for the course on payment of Rs. 1000.00 (for General and OBC students), Rs. 900/- (for OBC Non-Creamy Layer/ EWS Category) and Rs. 800.00 (for SC/ST/PWD students) through online payment. The weblink for the purpose shall be https://www.ausexamination.ac.in/admission.

Selection of candidates for Admission will be made on the basis of CUET (PG), 2023 score only. However, such candidates must submit a copy of their final result of Degree examination to the respective department within three days of result publication. Non-submission of degree final marksheet and non compliance of eligibility criteria of respective department shall automatically cancel the candidature.
